## Quotation for Consultancy Service Quotation Notice No: ADDA/DGP/ED/Q-07/2015-16.

The Executive Engineer, ADDA, Durgapur invites sealed quotation (Two Parts System) from list of Emplaned Firms of Govt. of West Bengal having experience in similar nature of work in any Govt./Semi Govt./Undertakings/Autonomous Body/Statutory Body (except joint venture firm / consortium).

**Name of the work :-** 1) Consultancy service for Construction of new bridge along with approach road beside the existing bridge situated beside City Centre Lake at City Centre, Durgapur-16. (2<sup>nd</sup> Call)

**Time of Completion :-** 20 (twenty) days.

**Scope of Work:-** (1) (a) Topographical Survey including Rout alignment of approach road (b) Traffic Survey for three days. (c) Route alignment including level survey. (d) Finalization of road width and ROW as per IRC norms and availability of land (e) Survey for road protection work (f) Soil investigation for sub soil and pavement (g) Pavement design and Geometric design of roads and drawing (h) Design and drawings of cross drainage structures and road protection works (i) Analysis of rate for different items of works. (j) Detail cost estimate for construction of bridge & road with BOQ required for tendering (k) Necessary documents to float NIT and specification of bidder as per norms and issuance of LOA.

(2) The DPR should be vetted from any Govt. Engineering Collage.

The Quotation should be submitted in sealed cover in two parts mentioning part No., Quotation No. and Name of the work on the top of the envelope of both the parts. Two parts shall be put together in a separate sealed cover. **First part** of the quotation shall contain credentials (Completion certificate) possessed by the firm during last five years, VAT Registration Certificate, P.T. Registration Certificate, PAN Card, Service Tax Registration Certificate. **Second Part** should contain only the price bid i.e. consultancy fee. The rate should be quoted on percentage basis on total estimated amount in two part i.e. Part- I and Part- II. The first part will be opened first and if the specific credentials are found acceptable as per terms and conditions laid down above, the second part that is financial offer will be opened on the same day or at a later date subject to clarification of any point related to first part. Rate should be quoted inclusive of all taxes, duties and should be valid for a year.

Quotation will be received in Tender Box up to 3.00 p.m. on **25.08.2015** at the chamber of Executive Engineer, ADDA at Durgapur office. Quotation will be opened on the same day at 3.30 p.m. at Durgapur office in presence of quotationers who may like to be present at that time. Detail information can be had from ADDA at Durgapur office during office hours. The Authority reserves the right either to accept or to reject any or all Quotation without assigning any reasons thereto.

The agency selected for the work will have to deposit an earnest money for an amount of Rs.20,000.00 in the shape of DD/PO in favour of ADDA payable at Durgapur within 7 (seven) days of opening of quotation failing which his Bid may be cancelled. Successful quotationer will have to make a formal agreement by purchasing 1set of tender document @Rs.1000.00 from our Cash Section.
