**The Technical Part** of the Tender shall contain earnest money (@ 2% of amount put to tender, in the form of D.D/Pay order drawn in favour of **Asansol Durgapur Development Authority** and credentials (Work Completion Certificate), documents e.g. ESI, VAT, PT Registration, Pan Card, EPF Registration, and Bidder Bank Account Details with IFSC Code etc.

**Financial Part:** - Should contain only price bid in Authority's tender form.

Technical parts will be opened first and financial part of only technically qualified bidders will be opened.

Notwithstanding the provision laid down in the agreement/ ADDA contract form, the contractor shall be liable to pay to ADDA any financial liability arising due to execution of any contractual work awarded by ADDA. Any such dues may be deducted from any bill of the contractor against any other work under ADDA.
