The above Quotation will be received in tender box up to **2:30 P.M. on 27-06-2016** at the chamber of Executive Engineer, ADDA at Asansol Office and will be opened on same day at **3:00 P.M.** in presence of tenderers who may like to present at that time.

The authority reserves the right either to accept or reject any or all tender without assigning any reason thereto.

Terms & Condition:

1. Earnest money of Rs.10, 000/- (Rupees ten thousand) only must be enclosed with the quotation by Demand Draft in favour of ADDA, payable at Asansol.
2. Earnest Money of unsuccessful bidders will be refunded after issue of Work Order. Earnest Money of successful bidder will be converted into security deposit.
3. Security Deposit shall be deducted from all type of bill as per Govt. rules and same may be refundable after defective liability period. Defective liability is one year from the date of completion of Work.
4. Credential from private organization and Gram Panchayet are not acceptable.
5. Contractor has to arrange all necessary machineries, tools, plants required for the work or specified & directed by EIC.
6. Total lowest amount will be considered for issuance of the Work Order, and not each item.
7. Pan Card, Professional Tax Certificate ,Trade License, VAT Registration Certificate, P.F. registration Certificate, E.S.I. registration Certificate and Bank solvency Certificate (25% of estimated amount put to tender and not more than one year old),Bank Account Details of the Bidder to be submitted with the Technical Bid document. Income Tax (Saral) Acknowledgement Receipt for the financial Year 2014-15 to be submitted. All taxes shall be deducted from all types of Bill as per Govt. rules. Challan of VAT and PF & ESI issued within previous six months from the month of floating NIQ has to be submitted. and Similar type of Credentials should be preferred but not less than amounting to Rs. 2 lakhs.
8. The Rate must be quoted in words and figure.
9. If the office happens to be closed on the date of receipt of the tender as specified, the tender will be received and opened on the next working day at the same time and venue.
10. Quotation may be sent through postal/courier service, but Authority will not be responsible for postal/courier delay.
11. Registered Unemployed Engineers' Co-operative Societies / Unemployed Labour Co-operative Societies are required to furnish valid Bye Law, Valid Register Certificate issued by the Co-operative Department. Current Audit Report, Annual General Meeting of 2014-2015 along with other relevant supporting papers.
12. Constructional Labour Welfare Cess @ 1 (one) % cost of construction will be deducted from every Bill of the selected agency, VAT, Royalty and all other Statutory levy / Cess will have to be borne by the contractor and the rate in the schedule of rates inclusive of all the taxes and cess stated above.
