NOTICE INVITING TENDER

1. For and on behalf of **Asansol Durgapur Development Authority**, Executive Engineer, ADDA invites sealed percentage rate Tender (Two bid system in Two Parts) from reliable and resourceful **eligible Electrical licensed contractors** having experience in executing similar type of works mentioned herewith valuing at least **40% of the estimated amount** against a single contract during preceding 5 (Five) years in Authority's contract form.

The Tender should be submitted in **sealed cover (only stippled is not acceptable)** in two parts mentioning part no, NIT No., and the name of the work on top of the envelope on the parts. Two parts shall be put together in a separate sealed cover.

- i) **The Technical Part** of the Tender shall contain earnest money (@ 2% of amount put to tender, in the form of D.D/Pay order drawn in favour of **Asansol Durgapur Development Authority Payable at Asansol** and credentials (Work Completion Certificate), documents e.g. Trade License, ESI, VAT, PT Registration, Pan Card, EPF Registration, Income Tax (Sara!) Acknowledgement Receipt for two consecutive years to be submitted i.e. the Assessment year **2014-15&2015-16**, Bank Solvency (**25% of estimated amount put to tender and not more than one year old**) etc. **Challan of VAT, PT, PF & ESI issued within previous Six months from the month of floating of NIT has to be submitted.**

- 2) **Financial Part:** - Should contain only price bid in Authority's tender form

Technical parts will be opened first and financial part of only technically qualified bidders will be opened.

- **Credential from private organization and Gram Panchayet are not acceptable.**

- **8% of bill amount shall be deducted as security money from all type of bills as per Govt. rule and security money will be refundable after defect liability period. Defect liability period is 1(one) year from the date of completion of work.**

If the office happens to be closed on the date of receipt of the tender as specified, the tender will be received and opened on the next working day at the same time and venue.

Tender may be sent through postal/courier service, but Authority will not be responsible for postal/courier delay.

The authority reserves the right either to accept or reject any or all tenders without assigning any reason thereto.

Additional Clauses-

1. Notwithstanding the provision laid down in the agreement/ADDA contract form, the contractor may be debarred from participating in further consecutive NITs floated from ADDA on account of poor performance. Assessment of poor performance and number of NITs to be debarred shall be the sole authority of ADDA and the decision shall be final in this regard.
2. Notwithstanding the provision laid down in the agreement/ ADDA contract form, the contractor shall be liable to pay to ADDA any financial liability arising due to execution of any contractual work awarded by ADDA. Any such dues may be deducted from any bill of the contractor against any other work under ADDA.
