Challan of VAT, PT, PF and ESI issued within Six months from the month of floating of e-NIT has to be Submitted and earnest money of Rs. 5,000 (Five Thousand) in the form of demand draft/pay order in favour of Asansol Durgapur Development Authority, payable at Asansol. Beside the item of quotation, the rate in lump sum basis(inclusive all taxes& duties) should be quoted by the bidder in both figure and words in their letter head
- The resourceful eligible Electrical licensed contractors having experience in executing similar type of works mentioned herewith valuing at least 40% of the estimated amount against a single contract during preceding 5 (Five) years in Authority’s contract form.


