Manufacturers should have adequate experience in manufacturing of their product and also satisfactory performance certificate from Govt./Govt. undertaking shall be furnished mentioning their pipes have been used in any major projects performing satisfactorily for a period of at least 3 (three) years or more issued by Govt. officials not below the rank of Executive Engineer.

- The latest valid BIS certificate for 300 mm. and 400 mm. dia.(K-9) pipes in favour of the manufacturer along with BIS Licence no.
- Photocopy of valid certificate from Pollution Control Board.
- The D.I. manufacturer should submit joint leak tightness certificate in relation to the clauses of 6, 6.3 note 1 and 15.1.2 of IS 8329/2000 to be carried out at the manufactures works.
- Certificate regarding "C" value test toward achieving "C" value 140 as per guideline of CPHEEO manual on water supply and treatment. C Value Certificate required for DI Pipe for 300mm and 400mm dia. D.I. pipe.
- Test certificate from reputed Govt. recognized testing agencies like National Test House etc. regarding suitability of DI pipes for use in contact with potable water should be furnished.
- They should have valid PAN No, VAT No, and Income Tax Clearance Certificate.
- They should produce latest DGS&D Registration Certificate if any.
- Acceptance clause of refund of Excise Duty & the clause of Sales Tax as per DGS&D Form No. 1001 clause No. 13 & 14. In this regard tenderers shall submit the undertaking at the time of submission.
- EMD of Rs 2,50,000/- (Rupees two lakhs fifty thousand) will be deposited by the bidder electronically : Online – through his / her net banking enabled bank account, maintained at any bank or Offline – through any bank by generating NEFT / RTGS challan from the e-tendering portal.
