

Ref. No. ADDA/DGP. TERMS & CONDITIONS Date:

- A. It shall be deemed that all the quotationer have thoroughly read and understood the terms and conditions of Quotation before quoting their rate both in figure as well as words an they shall have to sign this notice as a token of acceptance.
- B. Security Deposit as Earnest Money for Rs. 2,000.00 (Rupees two thousand) only in the shape of Bank Draft on any Nationalized Bank in favour of "Asansol Durgapur Development Authority" along with Auction paper should be submitted failing which the Auction paper is liable to be treated as cancelled.
- C. No materials other than cutting pieces of trees will be allowed to be lifted. In case of any materials other than above mentioned logs trees the quotationer will be put to legal action as per Rules. Also no damage to any properties during lifting of logs will be made.
- D. The officer conducting the Quotation may for sufficient reasons, which shall not be bound to be disclosed, refuse to accept the offer of the highest bidder and his decision shall be final and not to be opened to question.
- E. Within the specified date for issue of the permit, the purchaser shall have to remove the logs and clear the site properly, which shall include
 - i) Complete removal of said logs.
 - ii) Cleaning the site.
- F. After removal of logs quotationers will issue a certificate to the effect, that the entire work has been completed.
- G. The successful quotationers (Bidder) shall have to deposit the balance bid money by Bank Draft on any Nationalized Bank in favour of the "Asansol Durgapur Development Authority" within 2 (two) working days from the date of acceptance. Failing to deposit the balance bid money by Bank Draft within the period specified above, the security deposit shall forthwith stand automatically forfeited.
- H. The purchaser shall by the end of time allowed for removal of logs. Cleaning the logs sold promptly reporting to the undersigned , who in turn shall issue a certificate to the effect, that the entire work has been completed.

If the purchaser fails to comply with the terms and condition mentioned in paragraph "I" hereof he shall be held liable for damages in addition to the forfeiture of Security Deposit.
- I. During the period from the issue of the permit to the last date allowed for removal, the logs at the site will remain at the entire risk account responsibility and expenses of the purchaser.
- J. The purchaser shall be liable from & keep the undersigned saved harmless and indemnify against all action or suits, claims, damages, charges and expenses arising out/or in connection with the fulfillment of the terms and conditions of the removal of logs and cleaning the materials, whether employed provided however, that he will not have to indemnify the above officer and/or staff for any action that may question the legal right of the ADDA to disposal of the property.
- K. After the final acceptance of the bid, the successful Bidder shall have to sign a contract to the effect that he (the Bidder) fully understands all terms and conditions hereof, and in case of his failure to fulfillment any of the conditions, the Bid Money and Security Deposit, shall be forfeited by ADDA and the work or any part thereof lying or standing at the site after the period allowed for cleaning the site, shall become the property of ADDA and the undersigned shall be entitled to resell the same by another Public Auction.
- L. The carriage of logs shall not be carried out after the sun-set and before the sun-rise.
