(2) Trade Licence (3) GST registration No. / Certificate, (4) PT Registration certificate, (5) PAN Card, (6) Bank Solvency Certificate (25% of Estimated amount and not more than one year old) (7) E.P.F. Registration Certificate, (8) ESI Registration Certificate. Bank Solvency Certificate should clearly mention the amount of solvency. Bank transaction statement / balance of account on a particular date or over any financial quarter will not be accepted as bank solvency. Necessary Earnest Money will be deposited by the bidder electronically : Online – through his / her net banking enabled bank account, maintained at any bank or Offline – through any bank by generating NEFT / RTGS challan from the e-tendering portal. Intending Bidder will get the Beneficiary details from e-tender portal with the help of Digital Signature Certificate and may transfer the EMD from their respective Bank as per the Beneficiary Name & Account No., Amount, Beneficiary Bank name (ICICI Bank) & IFSC Code and e-Proc Ref No.

As per Govt. of West Bengal order No. HF/BHP/KFW/156/2007/311 dated 17.08.2007 Cess @ 1% of cost of construction will be deducted at source from the bill of the contractor engaged in the work. In case of Registered Labour/Engineers Co-operative society, they should produce photocopy of resolution of meeting of Board of Director empowering members to be Authorized Signatories of respective Co-Operative Society along with their application with the original resolution for verification. No conditional tenders will be accepted and the Executive Engineer, ADDA reserves the right to reject it without showing any reason. The Executive Engineer, ADDA reserve the right to cancel the e-NIT without assigning any reason and no claim for losses in this regard will be entertained. 
