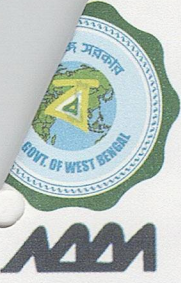

3. The items and quantity indicated in the table are tentative. The Authority reserves the right to increase or decrease the quantity or delete some or all the items depending on the needs without assigning any reason thereof.
4. All bids must be accompanied by a Demand Draft/ Pay Order as Earnest Money Deposit (EMD) of the amount of Rs.3,000/- (Rupees One thousand only) drawn in favour of "ADDA" payable at Durgapur. Any bid not secured with the EMD will be liable to be rejected by the Authority, as being non-responsive. EMD will be forfeited if a Bidder withdraws its bid during the period of bid validity specified as specified in this Bid Document. EMD of the successful Bidder will be forfeited if the successful bidder fails to carry out the work order issued. The EMD will remain in force up to 60(sixty) days after the period of Bid Validity. EMD of the successful bidder will be released after completion of the warranty period.
5. Delivery and installation to be completed within 7days on receipt of Work Order.
6. Warranty Terms: All items specified in Table will be covered by onsite warranty for a period of 1 years from the date of installation / commissioning.
7. Terms and conditions of the bidder sent along with the tender, if any, put by the Bidder shall not be binding on the Authority.
8. Payment to be made within 30days from date of delivery and completion of installation.
