The Technical Part of the Tender shall contain credentials (Work Completion Certificate with work order Similar Type), documents e.g. Trade & Electrical License with Electrical Supervisory License, Valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017, PT Registration, Pan Card, Income Tax (Sara) Acknowledgement Receipt for two consecutive years to be submitted i.e. the Assessment year 2020-21 & 2021-22, Bank Solvency (25% of estimated amount put to tender and not more than one year old), Challan of P.Tax, , initial earnest money of Rs.1,200/- (in the form of demand draft in favour of Asansol Durgapur Development Authority, payable at Asansol. Quoted by the bidder in both figure and words in it's letter head.
2. Earnest Money of unsuccessful bidders will be refunded after issue of Work Order. Earnest Money of successful bidder will be converted into security deposit
3. 1% of bill amount shall be deducted as security money from all type of bill as per Govt. rules and security money will be refundable after defect liability period. Defect liability period is three (3) months from the date of completion of Work.

7. The successful (Lowest) bidder will have to pay the balance amount of earnest money before issuance of work order if 2% of the earnest money is found more than 1200/- (One thousand two hundred only) in connection with the quoted amount.
