2. Bidders should have support centres at Durgapur or at Asansol. In case of support through service partners details of such service partners to be attached.
3. The Authority will arrange for ISP providing Internet Connectivity. However, the work of the selected Vendor will be to establish the Local Area Network in different segments and adjoining the segments into one network. The following is the primary scope of work.
  - i) Cat 6 Cabling using the switches and Mounting of Rack along with Patch Panel.
  - ii) Connectivity of Switches with Fibre Optics Cabling splashing and connection where required.
  - iii) Conduit Casing and PVC Piping in the corridors and outside where required
  - iv) Installation of I/O Box with reputed make and patch cords (moulded) of 3m for all nodes.
  - v) Dismantling of Old Cables and submission to the IT Cell.
  - iv) Setting up of individual IP address of the computers on network and security incorporated access point for users availing wi-fi services
  - v) Approximate: 10 NODES
  - vi) Installation and Maintenance of the LAN for a period of one year.
  - vii) Maintenance includes regular inspection of the wired cables. Cleaning of the Racks and fixing of loose end points along with other preventive maintenance.
