

The terms and conditions -

- 1) The authority reserves the right either to accept or reject any or all the bids without assigning any reason whatsoever.
- 2) Earnest Money of unsuccessful bidders will be refunded after issue of Work Order to the successful bidder. 2% of total quoted price of successful bidder will be considered as earnest money. Hence the successful bidder will have to deposit the balance amount was i.e. [(2% of total quoted price) – Rs. 1,000/-] in the form of demand draft in favour of “Asansol Durgapur Development Authority”, payable at Asansol. Earnest Money of successful bidder will be converted into security deposit.
- 3) 1% of bill amount shall be deducted as security deposit so that the total security deposit becomes 3% of total quoted price. Security deposit will be refunded after one year from the date of successful completion of the work. These one year is the defect liability period of the agency entrusted with the work. 
