Hence the successful bidder will have to deposit the balance amount was i.e. [(2% of total quoted price) – Rs. 1,000/-] in the form of demand draft in favour of “Asansol Durgapur Development Authority”, payable at Asansol. Earnest Money of successful bidder will be converted into security deposit.
- 3) 1% of bill amount shall be deducted as security deposit so that the total security deposit becomes 3% of total quoted price.
