Asansol Durgapur Development Authority (here in after call it as ADDA), A Statutory Authority of the Government of West Bengal, under Urban Development & Municipal Affairs Department constituted in compliance the West Bengal Town and Country (Planning and Development) Act, 1979 and the rules made there under and any direction which the State Government may give, from time to time.

### 1. INTRODUCTION:

Asansol Durgapur Development Authority invites e-Quotation from **eligible, bonafied reliable and resourceful bidders** for participation in the e-Quotation for selling of Scrap materials lying at Authority's store at Bidhannagar.

**4. EMD:**

An EMD amount of INR 10,000/- (Indian Rupees Ten thousand only) to be deposited **on-line by the bidders.**

**5. ELIGIBILITY TO PARTICIPATE IN e-QUOTATION:**

Bidders desiring to participate in this e-Quotation shall have to furnish copy of following documents:-

- i. Trade License,
- ii. AADHAR linked PAN No.,
- iii. EMD,
- iv. GST Registration Certificate.

**6. TERMS & CONDITIONS:**

- The successful bidder (H1) will be issued Work Order/ order of lifting of the materials and the (H1) bidder has to pay in advance before lifting of the materials.
- The payment invoice with regard to sale /disposal of scrap will be issued by ADDA inclusive of applicable GST.
- The Authority reserves the right to cancel the Work Order/ order of lifting at any moment without assigning any reason whatsoever.
- No material other than scrap material will be allowed to be lifted. In case of any materials other than above mentioned scrap the auctioneer will be put to legal action as per Rules.
- The bid without EMD will be liable for rejection straightway.
- ADDA will not entertain any claim for damage done, theft, fire or any other unforeseen calamity after realisation of full payment.
- It may please be noted that the EMD deposited by the successful bidder will be forfeited if the scrap items are not lifted from site within 5 days realisation of advance payment.
- The lifting of items must be done during normal working office hours.
- The lifting of the items shall be done without damaging the premises/ roads/drains/etc. The bidder shall compensate the damages, loss ets., in the event of any occurrence otherwise.
- No selection or sorting whatsoever of the material/ items will be allowed.
- Any unclear or unnoticed materials left over by the successful bidder within the premises cannot be claimed later.
- No enquiry of bidder shall be entertained once the scrap material is lifted.
- The materials being disposed of are to be treated in line with applicable rules/ notifications/guidelines etc. as may be prescribed by the Government. The successful bidder shall be responsible to ensure the compliance of the same.
- At any time ADDA may modify the bidding document by amendment thereon. The amendment will be notified on the website of ADDA only, which will be binding on bidders. Bidders should regularly visit the website [www.addaonline.in](http://www.addaonline.in) to keep themselves updated.
- Bidders not complying with the above conditions / clarifications are liable to keep to be rejected.
- All disputes including court proceedings shall be settled within the Durgapur jurisdiction only.

## 7. VALIDITY OF BID

All bids shall remain valid for 120 days from the date of closing of e-Quotation, excluding the date of closing.

## 8. FORCE MAJEURE

The provisions aforesaid shall not be limited or abrogated by any other terms of the contract whether printed or written.

## 9. DISPUTE RESOLUTION

The entire bidding process shall be governed by, and construed in accordance with, the laws of India and Courts in West Bengal shall have exclusive jurisdiction over all disputes arising under, pursuant to and/ or in connection with the bidding process, the subsequent licensee and the entire transaction, to the exclusion of all other courts in the world.
